

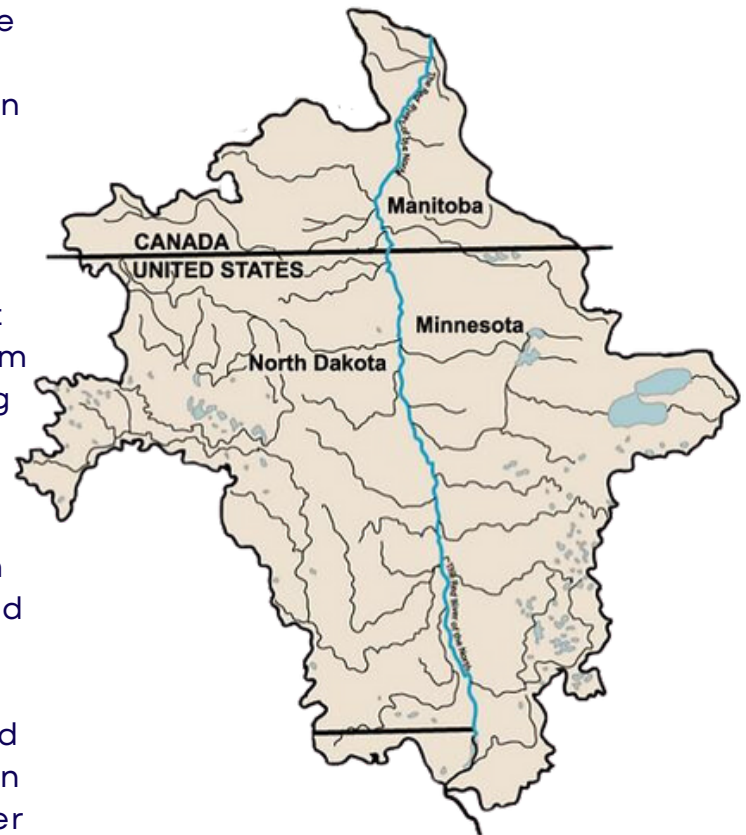


# RED RIVER BASIN COMMISSION

The Red River Basin is a special place and keeping it that way requires that people share the responsibility for its future. The RRBC brings people together to move common Basin goals forward.

The RRBC is a charitable, not-for-profit organization designed to help facilitate a cooperative approach to water management within the Basin and is a well-established forum for identifying, developing, and implementing solutions to crossboundary issues.

The RRBC is led by 44 directors representing the diversity of this multi-jurisdictional Basin and is comprised of local, state, provincial, and First Nation government representation, the environmental community, and at-large members. It maintains offices in Fargo, ND and Winnipeg, MB and is dedicated to innovation in the management of the Red River Basin's water resources.

The board keeps the IJC informed of basin activities that affect flows across the boundary, and water quality and ecosystem health in the Red River and its tributaries. The Board also monitors the implementation of flood-related recommendations made by the IJC.



## RED RIVER RETENTION AUTHORITY

The Red River Retention Authority is comprised of members of the Red River Joint Water Resource District, a North Dakota political subdivision, and the Red River Watershed Management Board, a Minnesota political subdivision. The primary objective of the Red River Retention Authority is to ensure joint, comprehensive, and strategic coordination of retention projects in the Red River of the North watershed and facilitating implementation and construction of retention in the Red River Valley.



## Prairie Water Committee

The central vision of Prairie Water is to enhance the resilience of prairie communities through the production of research that promotes sustainable water and watershed management. “Resilience” refers to “the capacity to adapt and recover from environmental change or impacts”, such as those associated with extreme weather events.

## RRBC

### Water Supply Working Group

Facilitates understanding and education of stakeholders throughout the basin on the potential for drought or other emergency water supply conditions; and ensure that the local plans have been coordinated regionally or from a basin wide perspective.

## Netley Marsh Project Committee

The Netley-Libau Marsh Restoration Pilot Project was started in 2018 by our project team. The project is a proof-of-concept study to determine the feasibility of restoring marsh vegetation. The Netley-Libau Marsh Restoration Pilot Project was designed under a straightforward scientific rationale by the project team.
